#### **Disclaimer**

The Company believes that the methodology prescribed by the Packaged Retail and Insurance-based Investment Products (PRIIPs) Regulation (the "Regulation") for the preparation of this document may be misleading to investors. The Company believes the Regulation is targeted at packaged retail investment products rather than shares in a listed company such as Tritax EuroBox plc. In line with the statement published by the Financial Conduct Authority on 19 September 2024 ("Statement on forbearance in relation to investment trust disclosure requirements") and in anticipation of a more appropriate regulatory framework for listed closed-ended investment companies (such as the Company), the cost disclosures set out herein now correctly reflect that there are no additional one-off, ongoing and incidental costs charged by the Company on an investment into its Ordinary Shares (which are admitted to trading on the London Stock Exchange's main market for listed securities).

# What is this product?

## **Product type**

Ordinary shares of 0.01 euro each in a UK public limited company which are listed on the premium segment of the Official List of the FCA and admitted to trading on the premium segment of the London Stock Exchange's main market for listed securities.

#### **Objectives**

The Company's investment objective is to invest in Continental European distribution or logistics real estate assets in order to deliver an attractive capital return and secure income. The Company seeks to meet its investment objective through investment in (including development), and management of, a portfolio of distribution or logistics assets in Continental Europe diversified by geography and tenant, targeting well located assets in established distribution hubs, within or close to densely populated areas. The Company may use borrowing on a prudent basis to purchase assets. The Company will maintain a conservative level of aggregate borrowings with a medium-term target of 45 per cent of Gross Assets and a maximum limit of 50 per cent of Gross Assets.

The Company intends to pay returns to investors by way of dividends on a quarterly basis in cash. The Company expects to pay out an annual dividend representing between 90 and 100 per cent of its Adjusted Earnings per Share ("Adjusted EPS") each year, with a minimum pay-out of 85 per cent of Adjusted EPS.

The payment and amount of future dividends paid by the Company is subject to the discretion of the Company's Directors and will depend upon, amongst other things, the Company successfully pursuing its investment policy and the Company's earnings, financial position, level and rate of borrowings and availability of profit, as well as the provisions of relevant laws or generally accepted accounting principles from time to time. There can be no assurance that any dividends will be paid in respect of any financial year or period and no guarantee as to the level of any future dividends to be paid by the Company.

Investors may also generate returns by selling shares through a stockbroker or bank. The Company's shares are bought and sold via the London Stock Exchange, and are only listed on that market and not traded on any other

market. Typically, at any given time on any given day, the price you pay for a share will be higher than the price at which you could sell it.

#### Intended retail investor

The Product is intended for institutional investors, professionally advised private investors and highly knowledgeable investors, each of whom intend to hold their investment for at least five years; have experience of investing in listed shares on regulated markets; understand and are capable of evaluating the risks of such an investment; and who have sufficient resources to be able to bear any losses (which may equal the whole amount invested) that may result from such an investment. Intended investors should also be seeking exposure to distribution and logistics assets that the Company will invest in, as part of their wider, diversified investment portfolio.

#### Term

The Product has no maturity date. Neither the Company nor the Manager can terminate the investment unilaterally.

# What are the risks and what could I get in return?

#### **Risk Indicator**



The summary risk indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets or because the Company is not able to pay out. We have classified this Product as 5 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity of the Company to pay you.

#### **Investment Performance Information**

The main factors likely to influence future returns are broad, and include the general economic and political conditions across the relevant EU Member States; including interest rates, inflation and the rising cost of energy and insurance which, in turn, impact investor appetite for the Company's shares. Additionally, factors impacting the global supply chain (such as the penetration of e-commerce or moves to on-shoring supply chains) can influence the demand for logistics and warehousing space. The Company has little influence or control over any of these factors

The Company relies on the continued performance of the Manager in carrying out all asset management, asset selection and financing decisions on behalf of the Company.

#### What factors could influence higher returns?

Any increase in the property valuation would increase the net asset value of the Company, which may influence the share price in the market. The successful identification and completion of asset management initiatives could lead to an increase in rental income. The prudent use of debt, competitively sourced, could reduce costs and amplify returns.

## What factors could influence returns negatively?

Costly asset management initiatives with no financial advantage will increase costs with no corresponding return. Any further erosion of economic conditions across the EU could lead to tenant default and therefore loss of rental income. A reduction in demand for logistics space caused by the aforementioned conditions could lead to landlords competing for tenants leading to both a reduction in rental levels and/or a reduction in asset values. The share price could negatively diverge further from the net asset value of the Company as macro-economic conditions influence investor behaviours across all sectors of the market.

#### What happens in severely adverse market conditions?

The Company's shares are traded on the Main Market of the London Stock Exchange and, therefore, subject to volatility based, not only, on the fundamental performance of the Company but also the supply and demand dynamics of a public market. In severely adverse market conditions, therefore, investors who sell their shares may receive a sum less than the net asset value per share and/or may only realise a price much less than that originally paid. Holders of the Company's shares may also experience a drop in the income return and/or a decrease in the net asset value per share if such severely adverse market conditions negatively impact the fundamental performance of the Company resulting in a cut to dividends paid and/or a reduction in the value of portfolio of property assets. Ultimately, if Company was wound up and the value of amounts owed to creditors exceeded the value of equity, shareholders may lose their entire investment but would not be liable for anything more.

# What happens if the Manager is unable to pay out?

The Manager manages the Company. You may suffer financial loss due to the default of the Company which could equal the amount of your investment. As an investor in the Company you will have no recourse to the assets of the Manager or right to claim to the Financial Services Compensation Scheme ("FSCS") about the Manager if the Company is unable to pay out. Also, as a shareholder of the Company you would not be able to make a claim to the FSCS about the Company in the event the Company is unable to payout.

## What are the costs?

The Reduction in Yield ("RIY") shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.
